

Natalie's Pet and House-Sitting Service Agreement

- *I agree to provide my services in a manner that is trustworthy, caring and dependable.
- *I am not responsible for any damage to the home beyond my control such as, but not limited to leaks, electrical problems or acts of nature. In these situations, I will attempt to contact the *Client* and/or designated emergency contact prior to a subjective decision on resolving any such issues. All repairs and related fees will be paid for by the *Client*.
- *I am not responsible for any loss or damage in the event of a burglary or other crime that should occur while under this contract. *Client* agrees to secure home prior to leaving the premises and I will re-secure home at the end of each visit. I will keep the *Client's* keys in a safe location.
- * *Client* will notify me of everyone who has been granted access to the home during the service period (example: housekeeper, friends/family members etc.). I accept no responsibility for security of the premises or loss if other individuals have access to a *Client's* home or if home is not properly secured.
- **Client* is responsible for pet-proofing house and yard, security fences, gates and/or latches. I will not be responsible or liable for the death, injury, disappearance, or legal consequences of any pet with unsupervised access to the outdoors.
- *I am authorized to seek any emergency veterinarian assistance needed during visits, at the cost of the *Client*, from any veterinarian as chosen by the *Client* or myself, should the need arise.
- *In the event of an emergency regarding your Pet(s), I am able to drop your Pet off at the emergency vet but I will not be able to stay with the Pet while waiting for care/receiving care. The *Client* will need to make arrangements with a friend/family member to wait with the Pet at the emergency vet and take the Pet to *Client's* home when they are released. I can resume pet care services (feeding/medicating/usual chores) at the *Client's* home if the Pet doesn't require specialized supervision throughout the day/night. If I am available to stay with the Pet and spend the day and/or night with the Pet, I will, and *Client* agrees to pay for this extra service. If I am unavailable for specialized supervision, *Client* will make arrangements with a friend/family member to take over the Pets care.
- *All pets must be currently vaccinated and on flea/tick prevention prior to service visit. If I am bitten or otherwise exposed to any disease or ailment received from *Client's* pet which has not been properly vaccinated or treated, it is the *Client's* responsibility to pay all costs and damages.
- *If you need to arrange a key pickup or drop off, you agree to pay the \$15 fee for each pickup/drop off.
- **Client* will be responsible for all medical expenses and damages resulting from an injury to me or other person(s), by the Pet. *Client* agrees to indemnify, hold harmless and defend me, in the event of a claim by any person injured by the Pet.
- *I will make every effort possible to see to your pet's safety and care in the event of a disaster, weather related or crisis but cannot guarantee it.
- *If you need to set up other in person meet ups after the initial Meet n' Greet (something in the routine has changed, pets' food/health/behavior etc. and you want/need to discuss it in person rather than by email/text), you agree to pay the \$30 fee for each extra in-person meet up.
- *I can end the service at any time that a pet poses a danger to the safety or health of itself, other pets or people. If concerns prevent me from continuing pet services, *Client* authorizes the pet to be placed in a kennel or previously arranged place if possible. All subsequent charges, including but not limited to transportation, kenneling, treating, accessing and liability are to be the responsibility of the *Client*.
- **Client* agrees to discuss any concerns with me within 24 hours of return after service.
- *This agreement is valid from the date signed to whenever services are terminated by the *Client* or myself.
- *This contract permits me to accept all future telephone or email reservations and provide service without additional signed legal agreements
- *The *Client* states that he/she has read this agreement in its entirety and fully understands and accepts its terms and conditions.
